Brief Description

Spanish Economy examines the main features of the economic structure of Spain. It covers important elements of economic growth, factor markets, the foreign sector and the Spanish public sector set in a European context. Moreover, Spanish Economy, with the help of economic analysis, offers students the opportunity to acquire skills and techniques for the interpretation of statistical data of the national economy and for the correct reading of economic reports produced by both public official institutions and academic research centres.

Previous Requisites

In order to maximize the learning results of this subject, the student should have the previous competences of:

- Calculus, in order to use this tool in logical deductions.
- Knowledge about the consumer's problems (maximization of the one used), producer's problems (maximization of the benefits), market organization (perfect competence, oligopoly, monopoly); all of them are studied in "Microeconomics I and II".

- 1. Analyse data of Spanish Economy aggregate magnitudes.
- 2. Identify Spanish Economy structural and institutional features, framed in the European and world economic reality.
- 3. Describe and study the main causes of Spanish processes, and define economic behaviour hypothesis to show prospective scenarios.
- 4. Understand the goods market, money and work behaviour of Spanish Economy.
- 5. Know the Spanish Public Sector organization.
- 6. Study deeply current and relevant issues for Spanish Economy.

- Assessment system

February/June call

Theory: 70% of final grade.

There will be two written exams:

First mid-term exam: 30%

Second mid-term exam: 40%

Practice: 30% of final grade

The practice part will be assessed by taking into account the student's involvement and participation in the different activities: hand out and correction of exercises, tasks, case studies and problems, performed individually or in groups. On the other hand, it will also be taken into account the public defense of the final task and the participation in forums of debate.

September Call:

Written exam: 70%

Students will do the mid-term exams failed in February-June call.

Practice part: 30% of final trade.

Students have to submit only one task under the title of "September Task of Spanish Economy"

February/June Call

The student will pass the subject in the February/June call when the arithmetic mean, according to the three grade percentages (two written exams and involvement) is equal or higher than 5, whenever none of the other two grades is lower than 5.

If the student has less than 5 points in any of the three grades (the two written exams and the involvement), he/she will have to retake those parts in September, keeping the grades equal or higher than 5.

September call

The student will pass the subject in September call when the arithmetic mean, according to the fixed percentages in three punctuations two written exams and involvement) is equal or higher than 5, whenever none of the other two grades is lower than 5.

In case of not passing, he/she will have to retake the complete subject in later calls.

Grading System

The grading systems (RD 1.125/2003. de 5 de septiembre) will be:

0-4,9 Fail (SS)

5,0-6,9 Pass (AP)

7,0-8,9 Grade B (NT)

9,0-10 Distinction (SB)

The "Honors" mention can be awarded to those students with a degree of 9,0 or higher. This cannot be awarded to more than 5% of the students registered in a subject in each academic year, unless the number of students registered is less than 20, when there will be awarded only one mention.

Recommendations for future study

We recommend doing previous readings of the subject materials and of chapters chosen from the basic and complementary bibliography, before attending theory sessions.

Instructional Material
