



CALL FOR UCAM-SPECIFIC RUSSIA-UKRAINE CONFLICT BASED SCHOLARSHIP SUPPORT FOR THE ACADEMIC YEAR 2022-2023

The Governing Council of UCAM Universidad Católica San Antonio de Murcia, in a meeting held on __ April, 2022, has approved this call for UCAM-Specific Russia-Ukraine Conflict based Scholarship Support for the academic year 2022-2023. All Ukrainian students who applied for the scholarship before 1st July 2022 are eligible, except those who already received prior approval for the scholarship, in accordance with the following:

GENERAL CONDITIONS

1. These are UCAM-specific scholarships and the amounts are as follows:

- New & Transfer applicants (academic year 22-23): 5 scholarships for Master's Degree from 30% to 50% of the tuition and 10 scholarships for Bachelor's Degree from 50% to 70% of the tuition divided and distributed into the programme duration. Admin fee not included in the scholarship.
- Current students (scholarship for the 2022-2023 academic year): 15 scholarships for Bachelor's Degree up to 100 % of the tuition. Admin fee not included in the scholarship.
- Exchange students on Campus: 5 scholarships up to 100% of the tuition. Admin fee not included in the scholarship.

2. The submission of applications to the UCAM Scholarship Commission begins on 1 June 2022 and ends on 30 June 2022. They shall be submitted by telematic means and the necessary documentation shall be available in the corresponding application enabled for this purpose on the University's web page (www.ucam.edu).

3. The selection of scholarship holders will be carried out according to the following criteria:

- To be Ukrainian nationals residing in Ukraine displaced since February 24, 2022.
- They should lodge an application for asylum or have a resolution by which temporary or international protection is granted
- Demonstrated financial impact directly related to the Conflict.

- Demonstrated economic needs caused by the Conflict according to the most affected areas, family sizes and ages.
- To anticipate the financial impact related to the current Conflict.
- No or limited access to other sources of financial support (other funds are not available to meet their essential needs, or are insufficient to meet these needs).

4. To be eligible for a UCAM scholarship, the following requirements must be met:

- A. Not to be a beneficiary of another scholarship previously approved. It cannot be clubbed with any other scholarship.
- B. The minimum requirements for admission to the program must be met.
- C. To be willing to take part in some of the programmes detailed in Annex 1.
- D. To have paid the application fee, pre-registration fee and other admin fees.
- E. The student must prove the financial impact suffered directly related to the Conflict. He/she must also prove to be Ukrainian nationals residing in Ukraine displaced since February 24, 2022.
- F. To submit the corresponding application in the official model, in due time and form, including all the necessary documentation.

5. Ukrainian nationals who justify the financial impact with documents and/or evidence can ask for the possibility of paying by installments. However, the following requirements and/or exceptions will be taken into account:

- Ukrainian nationals residing in Ukraine displaced since February 24, 2022
 - Application fee, pre-registration fee and reservation fee should all be paid before the start of the programme. Application fee will not be refunded if the student withdraws more than 28 days before the scheduled start date (as per the current approved exemption of the [Refund Policy](#)).
- 50% of the tuition fees should be paid by 1st January 2023
- only 3 installments will apply
- full fees should be paid before the end of the 2nd semester

6. Documents needed to be included in the scholarship application:

- Photocopy of the applicant's passport.
- An application for asylum or the resolution by which temporary or international protection is granted.

- Written statement from the student explaining how his/her financial situation has been affected and what economic needs have occurred including the affected area he/she is coming from, family size, ages.
- Any documentation/ Evidence of such impact, from the student or his/her legal guardians (at least an electronic version):
 - Cash movement report downloaded from bank account for the last months.
 - Letter from the employer; payrolls that reflect the variation in income; documentation proving the unemployment situation or reduction of labour income affecting the family unit due to the Conflict.
 - Documentation that proves the closure, suspension, or worsening of the business or company activity due to the Conflict.
 - Death or disability certificate of parents, guardians, spouse or partner, or other direct family members as a consequence of the Conflict.

7. The deadline for the processing and approval of this call:

- Once the requirements have been submitted, the Regional Heads or International Marketing Deputy Director will interview the applicant.
- The recommendation and comments will be sent to the Director of International Development for final approval.
- All scholarship applications will be processed on a first come first serve basis.
- Applications submitted after 1st June will no longer be accepted.
- Scholarship approval and/or rejection will be confirmed on 30th June.
- No approval and rejection will be given after 30th June.

8. The Conflict scholarships and grants in this call are incompatible with those provided by other bodies during the 2022/2023 academic year in any of their forms, as well as with other benefits of the same purpose that may be received from other entities or persons, whether public or private. No student may receive more than one scholarship, even if he/she is undertaking several studies at UCAM at the same time.

9. The presentation of the application form in a pdf file signed by the interested party will mean the acceptance of the rules and requirements of the call:

- A. He/she is aware that the inaccuracy, omission or falseness of the data and circumstances declared will result in the rejection or revocation of the scholarship, incurring legal responsibility as appropriate, in addition to any disciplinary measures that may be agreed upon by the UCAM Disciplinary Commission.
- B. The applicant authorizes receiving information about the resolution via email.
- C. He/she is aware of the regime of incompatibilities of this call and in case of obtaining another scholarship or aid from any Administration or public or private entity, the student must inform the UCAM Scholarship Section.
- D. In compliance with the provisions of Law 15/1999 on Personal Data Protection, the information provided will become part of the AIDS AND SCHOLARSHIPS corresponding to the automated file of STUDENTS in order to manage their scholarship file. The student has the right to access this information, rectify it or cancel it, by contacting the address of the entity responsible for the processing, Fundación Universitaria San Antonio, at Campus Los Jerónimos, S/N, 30107 Guadalupe (Murcia). This entity guarantees the adoption of appropriate measures to ensure the confidential processing of all the data.

10. Supervision of compliance with the purpose of the scholarship. To this end, it will be understood that the scholarship has not been assigned for this purpose when one of the following situations occurs, and the scholarship will be refunded:

- 1. Cancellation of matriculation.
- 2. In the event of discovering that there was concealment or falsification of data in its granting or that there is an incompatibility with other benefits of this kind from other natural or legal persons. They will also be refunded if it is proven that they have been granted to students who did not meet any of the established requirements, or who do not properly accredit them.


11. A collegiate body for the selection of scholarship holders will be set up to study the applications submitted and to select potential scholarship holders. This body will examine the applications submitted and will ask the interested party, if necessary, to correct any defects or to submit the required documents within ten days of receiving the request, indicating that, if he or she does not do so, the request will be deemed withdrawn.



The Selection Committee will check that the applications submitted meet the general requirements for granting. Either of the scholarships may not be awarded if candidates do not meet the requirements described in the previous points. The Commission also reserves the right to modify or remove the scholarship component of this call in response to unforeseen circumstances.

Scholarship applicants who are denied this right may appeal to the Governing Council of this University within 7 calendar days. If the appeal is denied, no further complaint will be possible.
